

ORDINANCE NO. 1186

AN ORDINANCE AMENDING CHAPTER 14.04.240 OF THE FAIRFIELD MUNICIPAL CODE PROVIDING AND RETAINING RESIDENTIAL CUSTOMER SECURITY DEPOSIT OF UTILITY SERVICES.

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:

Section 1. PURPOSE AND INTENT

It is the purpose and intent of this amendment to align fees furnished and retained for Residential Customer Security Deposit of utility services will help ensure the total amounts owed for utility services received, including any applicable penalty charges and reconnection fees, are paid to the City of Fairfield. It is based on the principal that the person using the same should pay the determined reasonable cost

Section 2. REPEALER. The Fairfield Municipal Code 14.04.240 is hereby amended to update Residential New Customer Deposit and procedures by deleting:

(b) Charges associated with utility billing shall be as follows:

(b) Charges associated with utility billing shall be as follows:


Residential Customer Security Deposit	\$125.00 – Refundable after termination of service

Section 4. SEVERABILITY CLAUSE. If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such an adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 5. EFFECTIVE DATE. This Ordinance shall be effective after its final passage, approval and publication as provided by law be in full force and effect.


