

ORDINANCE NO. 1172

AN ORDINANCE AMENDING THAT PART OF ORDINANCE 968 (2002) WHICH ESTABLISHES THE BEAUTIFICATION COMMISSION (Codified as 20.86.010) TO INCREASE COMMISSION MEMBERSHIP FROM NINE TO TEN MEMBERS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FAIRFIELD, IOWA, THAT:

Section 1. REPEALER. That part of Section 20.86.010 which provides as follows: “an advisory body to be composed of nine persons...” **IS HEREBY REPEALED.**


Section 2. SUBSTITUTING AMENDMENT. That part of Section 2.86.010 shall now read as follows: “an advisory body, to be composed of ten persons (each with staggered terms of service).”

Section 3: SEVERABILITY CLAUSE. If any section, provision, or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

Section 3: EFFECTIVE DATE. This Ordinance shall be in full force and effect immediately after its final passage, approval and publication as provided by law.

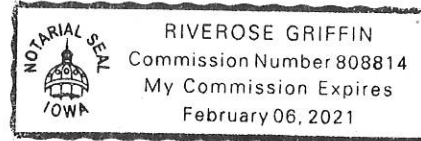
