

ORDINANCE NO. 1170

**AN ORDINANCE AMENDING CHAPTER 10.42.010 OF THE FAIRFIELD
MUNICIPAL CODE – CONCERNING DESIGNATED SCHOOL ZONES**

BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:

Section 1. REPEALER. Fairfield Municipal Code Section 10.42.010 is Amended by removing the following subsections:

- (2) That part of West Stone Avenue commencing at the intersection of North Third Street and running thence west to North Sixth Street;
- (3) That part of North 5th Street commencing at the intersection of West Stone Avenue and running thence south to West Lowe;
- (5) That part of West Stone Avenue commencing at the intersection of North Eighth Street and Running thence west to North Tenth Street;
- (18) That part of North Second Street commencing at the intersection of West Lowe Avenue and running thence north to North Stone Avenue;
- (19) That part of West Kirkwood Avenue commencing at the intersection of North Main Street and running thence west to North Third Street.

THE ABOVE RESPECTIVE SUBSECTION ARE HEREBY REPEALED.

Section 2. AMENDMENT BY SUBSTITUTION. Fairfield Municipal Code Section 10.13.070 is Amended by Substituting the following subsections:


- (1) That part of North Fourth Street commencing at the intersection of Merrill Avenue and running thence north to a point 800 feet north of the centerline of Carpenter Avenue.

Section 3. SEVERABILITY CLAUSE. If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such an adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


Section 4. EFFECTIVE DATE. This Ordinance shall, after its final passage, approval and publication, as provided by law, be in full force and effect.

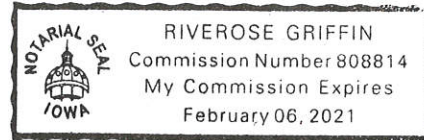
