

**ORDINANCE NO. 1169**

**AN ORDINANCE AMENDING CHAPTER 10.13.070 OF THE FAIRFIELD  
MUNICIPAL CODE – CONCERNING CROSSWALKS**

**BE IT ORDAINED BY THE CITY COUNCIL OF FAIRFIELD, IOWA:**

**Section 1. REPEALER.** Fairfield Municipal Code Section 10.13.070 is Amended by removing the following subsections:

- (3) On the west side of the intersection of West Stone Avenue and North 5<sup>th</sup> Street;
- (4) On the north side of the intersection of West Stone Avenue and North 9<sup>th</sup> Street;
- (5) On the west side of the intersection of West Kirkwood and North 5<sup>th</sup> Street;
- (33) On the west side of the intersection of Merrill Avenue with a point known as “Carter Drive”;

**THE ABOVE RESPECTIVE SUBSECTION ARE HEREBY REPEALED.**

**Section 2. AMENDMENT BY SUBSTITUTION.** Fairfield Municipal Code Section 10.13.070 is Amended by Substituting the following subsections:

- (1) The intersection of North 4<sup>th</sup> Street and a point approximately 675 feet north of the centerline of Carpenter Avenue;
- (2) On the east side of the intersection of North 4<sup>th</sup> Street and Stone Avenue;
- (32) On the west and south sides of the intersection of side of the intersection of North 4<sup>th</sup> Street and Carpenter Avenue;

**Section 3. ADDED.** Fairfield Municipal Code Section 10.13.070 is Amended by Adding the following subsection:

- (43) The intersection of North 4<sup>th</sup> and a point approximately 140 feet north of the centerline of Carpenter Avenue;
- (44) On the north, south, east and west sides of the intersection of Fillmore and Sixth Street.
- (45) On the west side of the intersection of School Place and Sixth Street.

**Section 4. SEVERABILITY CLAUSE.** If any section, provision or part of this Ordinance shall be adjudged to be invalid or unconstitutional, such an adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


**Section 5. EFFECTIVE DATE.** This Ordinance shall, after its final passage, approval and publication, as provided by law, be in full force and effect.

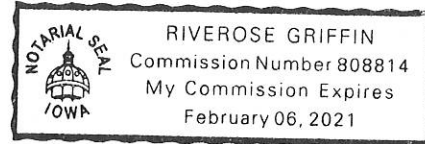
